Late Filing



The company and every officer could be fined up to €1,905 if the Annual Accounts are not sent in by the due date.

A late filing penalty of €100 becomes due on the day after the expiry of the due date and a charge of €3 per day will be applied thereafter up to a max of €1,200 per return.

In addition, the company may be struck off the register and dissolved, the directors disqualified and the company prosecuted.
